3. Description of the training offered:

Trainees have the opportunity to become a Patient Care Technician (PCT). This 9-week training program assists students in obtaining higher level skills needed to perform advanced nursing tasks. The training program focuses on advanced nursing skills including wound care, tracheotomy and ostomy care, catheterizations, Electrocardiography (EKG), and phlebotomy tasks. The training meets during the evenings twice per week for 4 hours (T, R 5-9:15pm).

5. Am I eligible?

To be eligible for this training program, applicants must:

- Be at least 18 years of age
- Be a Maryland resident
- Have a High School Diploma or GED®
- Have a sincere desire to work within the healthcare industry

- Be committed to completing all requirements of the program
- Be willing and able to obtain employment upon training completion
- Be a licensed Certified Nursing Assistant with one year of documented experience
- Submit proof of current Health Care Provider CPR certification
- Successfully pass both a federal and state background check
- Successfully complete a drug screening
- Provide results of a Tuberculosis skin test (PPD) or clear chest X-ray if PPD results were previously positive. PPD results must be no more than 12 months old when beginning clinical rotation
- Provide proof of measles, mumps, and rubella (MMR) immunizations or positive titer
- Provide proof of completion of Hepatitis B vaccination series or sign a waiver releasing the College and clinical site of any legal or medical responsibilities resulting from exposure to the Hepatitis virus
- Provide proof of varicella immunization or positive titer
- Provide proof of influenza vaccination (seasonal)

7. How much can I expect to earn if I complete this program and obtain employment as a Certified Patient Care Technician (PCT)?
