Thank you for your interest in the Maryland Apprenticeship Ambassador Program!

The Maryland Department of Labor, Licensing and Regulation is committed to fulfilling Governor Hogan's promise and mission to change Maryland for the better. Developing Maryland's apprenticeship program is a big part of that change, and a priority for our agency.

The Hogan administration's commitment to apprenticeship has shown significant results. Since January 2015, the number of registered apprentices has increased by nearly 20 percent. New registered apprenticeship programs have been approved and old programs re-activated. Now, nearly 9,600 registered apprentices are learning and earning in more than 230 occupations. All in all, 2017 was a banner year for the Maryland Apprenticeship and Training Program.


If you are interested in becoming an apprenticeship ambassador, here is your next step. Please take a few minutes to answer the following questions:
